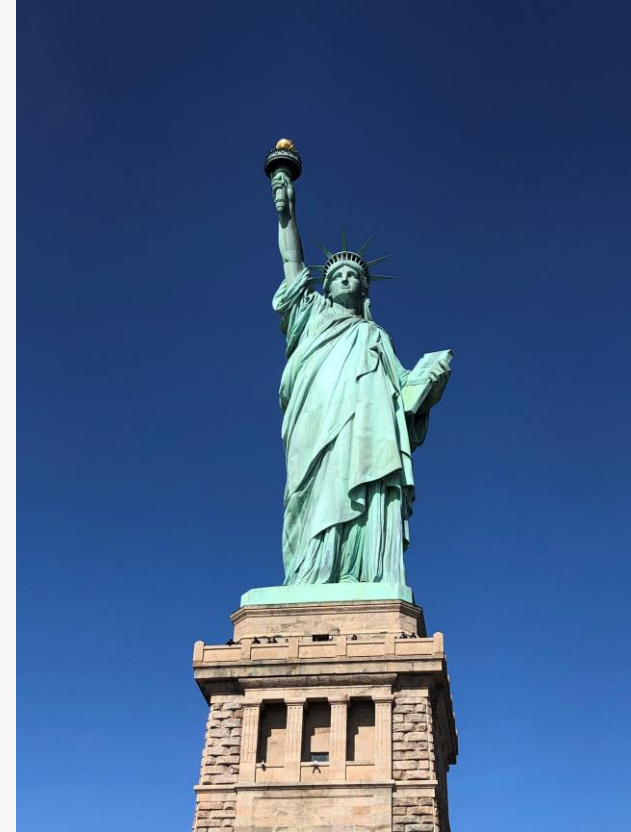

- **Friends of Fondation de France, Inc.**

is a 501(c)(3) public charity (EIN 13-3966503) established in 2000 to provide an easy, and trustworthy way for donors based in the United States to support nonprofit projects abroad while receiving fiscal benefits to the extent allowed by the law.

- **How can your organization benefit from this scheme?**

Step 1 : you prepare your application file, with our support, and submit it for instruction and validation by Fondation de France and Friends of Fondation de France.

Step 2 : after your project is approved by our board, your donors can make their gifts through Friends of Fondation de France, dedicating it to your organization.

Step 3 : Friends of Fondation de France wires the funds to Fondation de France, and Fondation de France transfers them to your organization, net of transaction costs.

Step 4 : one year after you receive the funds, your organization must provide Friends of Fondation de France with a report on the use of funds.

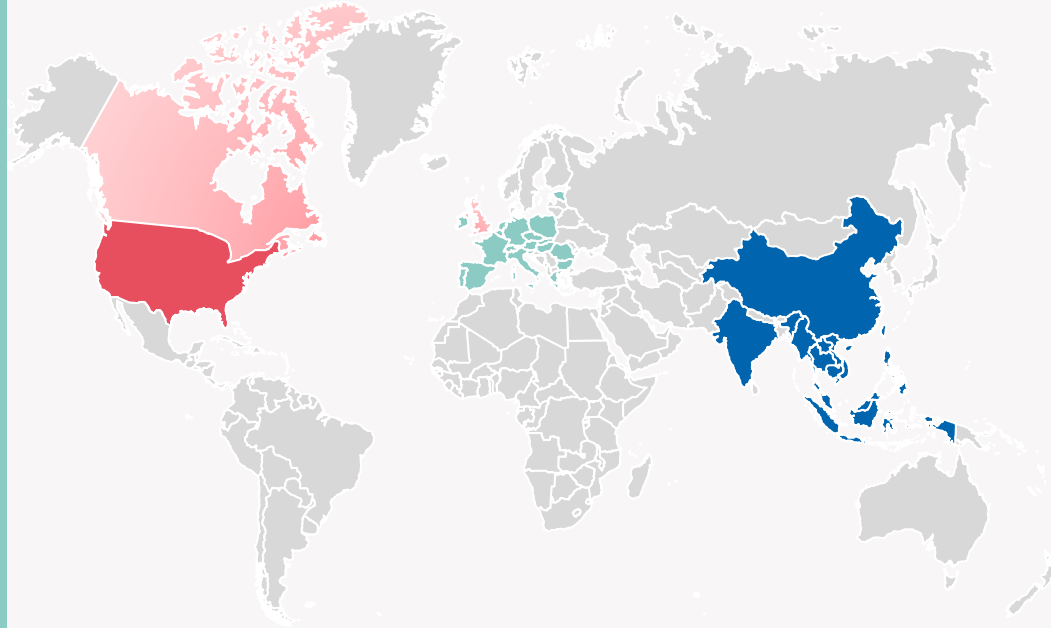
